Senate/39/01	Overview Report of the Chairperson

The Chairperson, Senate welcomed all the members in the Senate. In the Semester- 1, 2016-17, 175 UG students (out of 770 students) got 'A' and 4 students got 'O' grades. In master programme, 34 students got 'A' out of 154 students. In this semester, 17 students from UG and 5 students from PG secured 10.0 SPI. Also, programme of 10 students (out of 13) have been restored by SENATE through resolution by circulation. In this semester, 9 UG students and 1 PG student visited JAPAN JENESYS program for a week for their exposé in academic activities. Our students participated in inter IIIT sports meet 2016 at Kanchipuram and awarded 8 gold medals, 5 silver medals and 3 bronze medals, stood 2nd overall. Dr. Jawar

Singh visited University of North Texas, USA under BHAVAN-2016 fellowship by Indo-US Science and Technology Forum, IUSSTF, New Delhi for five months and returned back after successful completion of program.

The Director also advised that the approval for the new course should be taken well in advance before the starting of the semester. For the semester commencing in August and January, the approval must be taken in January and August, respectively and the names of the courses to be listed on the website.

The Ordinances of the PDPM IIITDM Jabalpur have been notified in Gazette of India on December 9, 2016.

The external Senate member Prof. V. M. Gadre could not attend the meeting due to his pre-occupation at IIT Bombay; however he has conveyed his comments. The comments/suggestions sent by him are well taken by the Senate.

The Dean (Academic) placed the following two such cases:

(a) Ms Vandana Arora, Ph.D. student of Prof. Tanuja Sheorey, has completed maximum limit of 6 years.

(b) Mr Dharendra Singh, M.Tech, CSE working under the supervision of Dr. Atul Gupta completed maximum limit of 04 years.

Both these cases were discussed by the Senate and the Senate granted extension of 6 months as a special case. The students have to submit their thesis within this period and no further extension will be granted. The supervisors are also advised to ensure that the students complete their work and submit the thesis within the extension period granted to them. The request of Ms. Vandana Arora for providing her additional supervisor has not been accepted at this stage by the Senate.


approval, the Senate decided that the Dean (Academic) is to relook these new courses and place the recommendation before the Chairperson, Senate for approval.


